

STYLE GUIDE

Preliminary Remarks

- Use footnotes **only** for additional information
- In the text: Footnotes **after** the punctuation
- End footnotes **always** with punctuation
- Complete bibliographical notes only in the list of references at the end of the article. For bibliographical notes in the article, use a bracket before the punctuation: (Author_Year:_Page), for example: (Emmers 2010: 10)
- Do not use "ibid." when referring to the same work twice in succession
- No period at the end of the biographical notes in the list of references
- Do not divide the list into different sections (books, reports, newspaper articles etc.)
- Is there more than one reference to the same author, that author's references should appear in chronological order and replace the authors name with an em dash —

in short

- author = Last name, first name
- editor = ed.
- editors = eds.
- no named publisher = s.n.
- no place of publication = s.l.
- no date = n.d.
- translator = trans.

For three or more authors, list all of the authors in the reference list; in the text, list only the first author, followed by et al. ("and others"): (Barnes et al. 2010)

Journal article

Article in a print journal

In the text, list the specific page numbers consulted. In the reference list entry, list the page range for the whole article.

Article in an online journal

Include a DOI (Digital Object Identifier) if the journal lists one. A DOI is a permanent ID that, when appended to <http://dx.doi.org/> in the address bar of an Internet browser, will lead to the source. If no DOI is available, list a URL and in both cases include an access date.

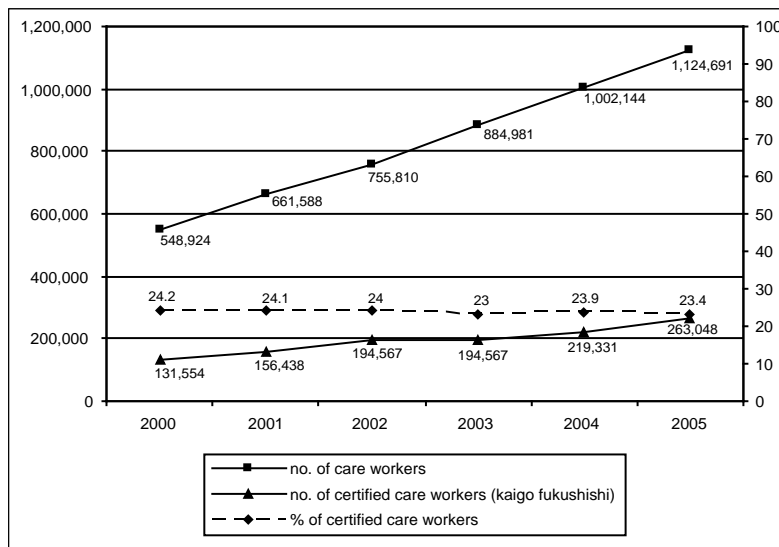

MISCELLANEOUS

- Please avoid using footnotes wherever possible.
- Do not include any footnotes and references in your abstract or headings
- You may use up to three levels of heading in the text to help guide readers around your paper
- Use American English spelling (except for British English proper names)
- Use italics for emphasis, not bold, underlining or single quotation marks
- Use square bullet points in the text for lists and the like
- Use double quotation marks
- Dates should be in the form of "month day, year", eg. May 10, 2014
- When using abbreviations or acronyms, spell them out in full on their first use. Do not use full points within abbreviations or acronyms
- Quotations in the text of more than 30 or so words should be pulled out of the text and indented. Indented quotations should not be put in quotation marks
